Moving to Kingman? Information/FAQs

WELCOME TO THE CITY OF KINGMAN- A Great Place to Land! To help your transition to our city, we have collected answers to frequently asked questions. The city's website, www.cityofkingman.com, is also a great source of information. If you need additional information or have questions, please contact City Hall.

Electric, Sewer, and Water: The City operates these three utilities. The city has its own electric generating plant, wastewater treatment plant, and its own water wells. Charges for all three utilities are combined into one bill and must be paid in full by the 10th of each month. Payment policies are provided when utility applications are received. Payment may be made at City Hall, over the telephone, or online. For utility problems related to electric, sewer, or water, please call 532-3111 during regular business hours. For problems after regular business hours, weekends, or holidays, please call 532-2131 or 532-3138. Basements and cellars with plumbing fixtures connected to the sanitary sewer line shall be provided with a back-water trap or gate valve. Property damage resulting from backup sewage is the homeowner's responsibility.

Gas Service: Contact Kansas Gas Service at 1(800)794-4780 (24-hour service).

Cable television: Contact Cox Cable Television at 1(800)234-3993.

Telephone: Contact AT&T for local service at 1(800)288-2020.

Garbage and/or Trash Pickup: Waste Connections is franchised through the city. For questions or service call Waste Connections at 316-838-4920.

Driver's License Renewals/Exam Station: Kingman County Courthouse, 130 North Spruce, 2nd Floor, Kingman, 532-5080. Check with office staff for hours of operation.

Voter Registration: City residents, 18 or older, may register at City Hall or the Kingman County Courthouse.

Building Permits: Contractors must be licensed by the city and present at the inspection. No building on any structure shall commence before obtaining a building permit from the City Inspector. Permits are also needed for electric, plumbing, and gas.

Pets: Cat and/or dog tags are required within 30 after moving to the City. A rabies certificate dated within the past year is needed to purchase a tag. All dogs and/or cats must be confined in some manner and at no time allowed to run loose within the City limits. Some dogs are prohibited by City ordinance.

Burning of Trash: A permit is required to burn trash within the City. Burn permits are available at City Hall.

Internet Services: Several internet providers are available to residents of Kingman. Cox, AT&T, Dish Network, KanOkla, and Nextlink Internet provide service to the area. For pricing information please contact the service providers.

General Public Transportation: The City operates a general public transportation system. Fares are \$1.00 per person, per destination. Buses operate within the city limits and are taken on a first come, first serve basis. To request a ride, contact dispatch at 532-1130.
