## **KINGMAN FIRE DEPARTMENT BURNING PERMIT REQUIREMENTS**

**By accepting this permit, I agree to abide by the following requirements:**

1. The applicant is in legal control of the lot or parcel of land herein described.
2. Burning will be attended continuously by a competent person of legal age from the time of ignition until the time of extinguishment.
3. Burning will not be permitted if the wind speeds are in excess of 15 MPH.
4. For field type fires: A Firebreak (plowed or disked) of at least 20 foot on all sides of the area to be burned shall be provided.
5. For non-field type fires: Adequate clearance shall be provided from readily combustible material.
6. Burning shall not create a nuisance, or hazard, to neighboring properties or persons. Precautions shall be taken to ensure confinement, intensity, and size of burn.
7. **BURNING OF ANY MATERIALS PRODUCING HEAVY SMOKE IS PROHIBITED! THIS INCLUDES, BUT IS NOT LIMITED TO TIRES, PLASTICS, ROOFING, TARPAPER, FURNITURE, GARBAGE, ANIMAL WASTE, CLOTH, OR ANY PETROLEUM BASED PRODUCT.**
8. A garden hose of other fire extinguishing equipment shall be available at the burn location.
9. Burning shall be conducted one hour after sunrise to one hour before sunset except specifically approved fires.
